乙太網路交換機第一名: 2009年小型企業市場.以全球埠數出貨量計

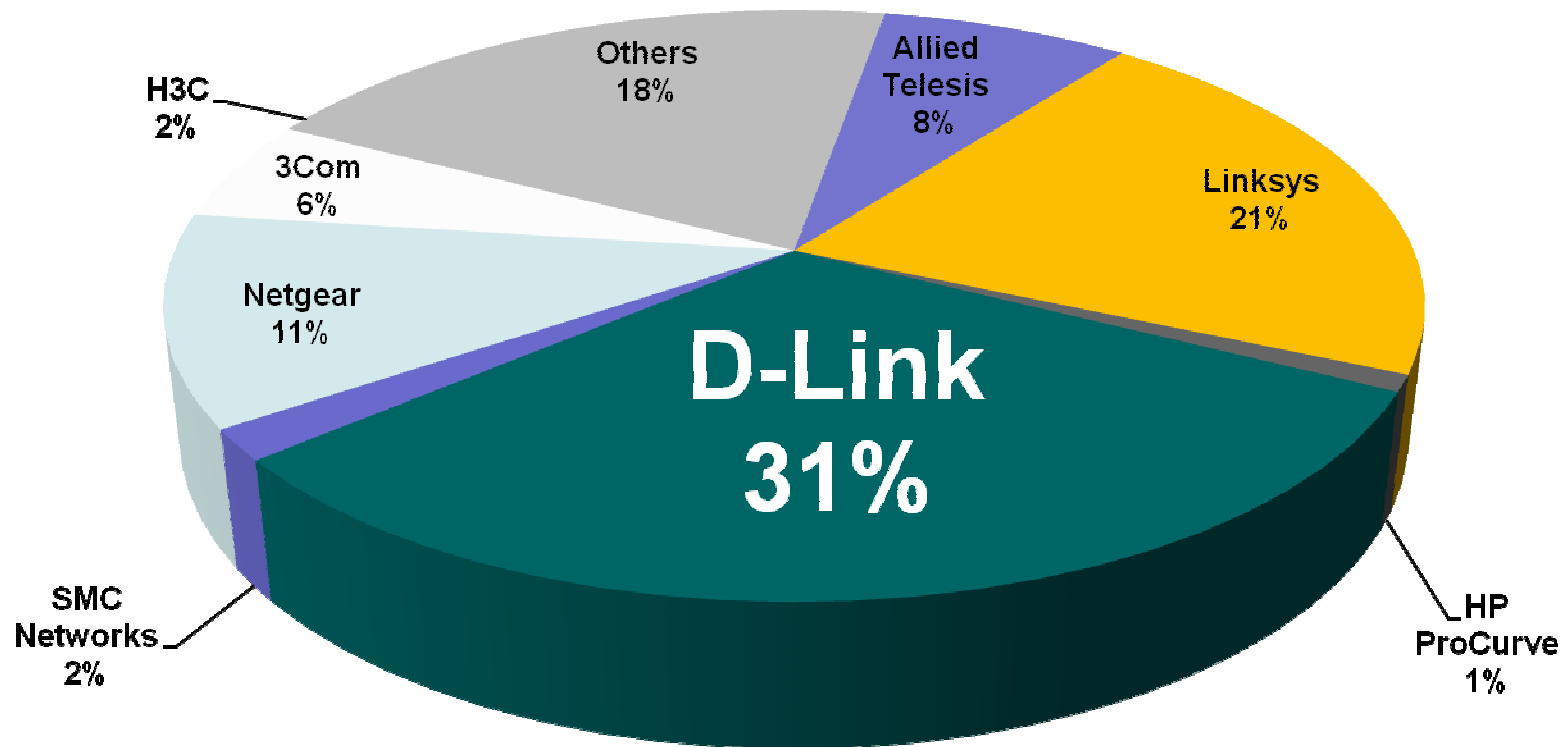

無線網路單機接入點第一名: 2009年小型企業市場.以全球單位數出貨量計

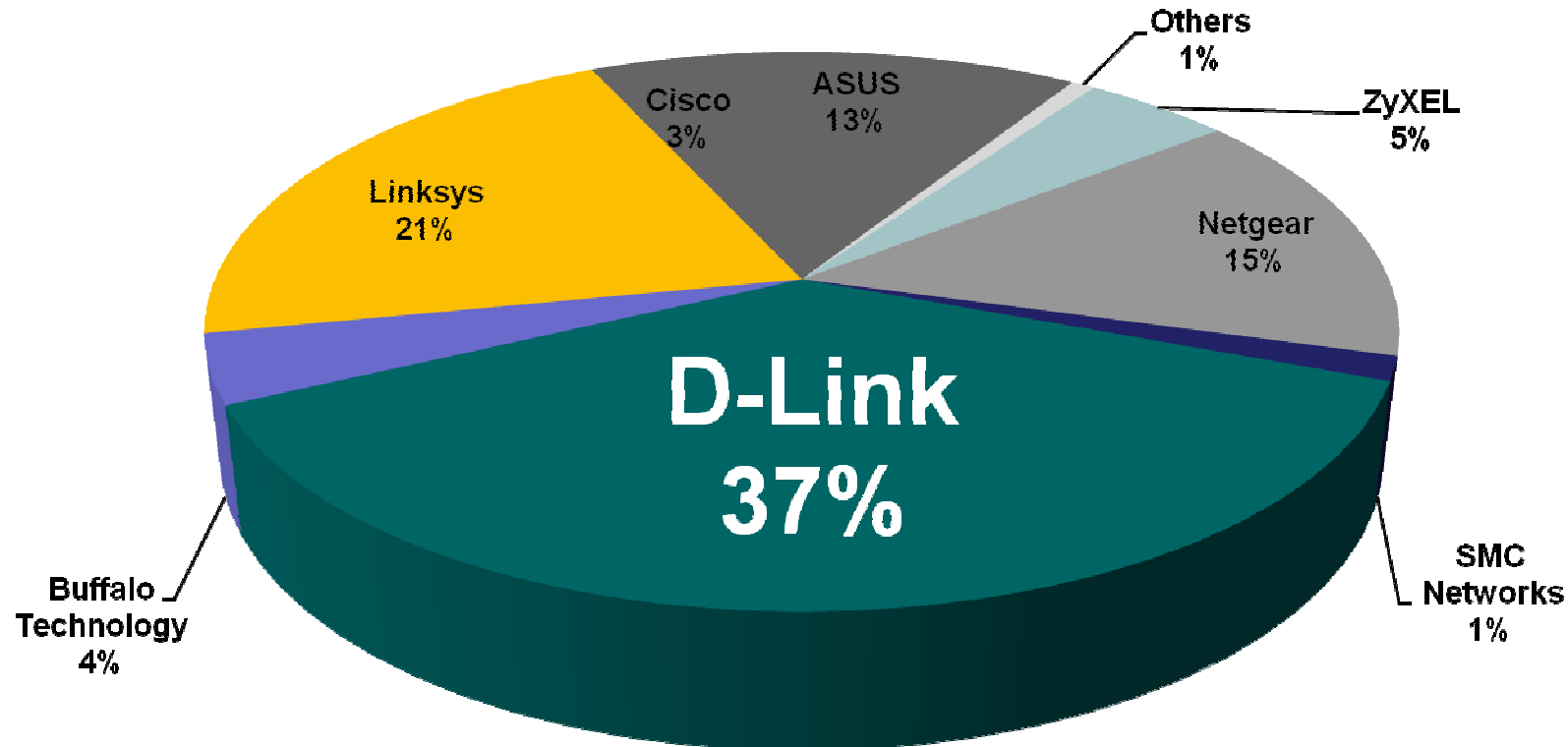
