

## Alpha Networks Inc. Reports Second Quarter 2012 Results

Hsinchu, Taiwan, August 24, 2012 -- Alpha Networks Inc. (TWSE: 3380) today announced its consolidated financial results for the first half and the second quarter of 2012.

The consolidated revenue for the first half of 2012 was NT\$13,161 million, up 10% on a year-over-year basis. The net income after tax was NT\$398 million, up 29% year over year, and EPS after tax was NT\$0.78. 1H12's revenue by product categories: LAN/MAN accounted for 49% of 1H12 consolidated revenue, followed by Wireless at 28%, Mobile & Broadband at 9%, Digital Multimedia at 12%, and Others at 2%.

The consolidated revenue for 2Q12 was NT\$6,839 million, up 8% from 1Q12. The net income after tax was NT\$261 million, up 91% quarter over quarter, and EPS after tax of 2Q12 was NT\$0.51. 2Q12's revenue by product categories: LAN/MAN accounted for 48% of 2Q12 consolidated revenue, followed by Wireless at 29%, Mobile & Broadband at 9%, Digital Multimedia at 12%, and Others at 2%.
