

## Alpha Networks Inc. Reports Second Quarter 2014 Results

Hsinchu, Taiwan, August 11, 2014 -- Alpha Networks Inc. (TWSE: 3380) today announced its consolidated financial results for the second quarter of 2014.

The consolidated revenue for the first half of 2014 was NT\$11,434 million, up 4.7% on a year-over-year basis. The operating margin was up 7.5% YoY because of a decrease in operating expenses. The net income after tax was NT\$146 million, down 41.7% year over year due to the non-operating loss, and EPS after tax was NT\$0.30. 1H14's revenue by product categories: LAN/MAN accounted for 51% of 1H14 consolidated revenue, followed by Wireless at 28%, Mobile & Broadband at 8%, and Digital Multimedia at 13%.

The consolidated revenue for 2Q14 was NT\$5,997 million, up 10.3% QoQ. Net income was NT\$97 million, up 98.6% QoQ. EPS after tax for 2Q14 was NT\$0.20. 2Q14's revenue by product categories: LAN/MAN accounted for 53% of 2Q14 consolidated revenue, followed by Wireless at 25%, Mobile & Broadband at 7%, and Digital Multimedia at 15%.
