

## Alpha Networks Inc. Reports Fourth Quarter 2014 Results

Hsinchu, Taiwan, March 18, 2015 -- Alpha Networks Inc. (TWSE: 3380) today announced its unaudited consolidated financial results for the fourth quarter of 2014.

The consolidated revenue for 4Q14 was NT\$6,280 million, up 12.9% from 3Q14. The net income after tax was NT\$255 million, up 88.9% quarter over quarter, and EPS after tax of 4Q14 was NT\$0.52. 4Q14's revenue by product categories: LAN/MAN accounted for 51% of 4Q14 consolidated revenue, followed by Wireless at 26%, Digital Multimedia at 12%, Mobile & Broadband at 9%, and Others at 2%.

The consolidated revenue for 2014 was NT\$23,278 million, down 3.4% on a year-over-year basis. The net income after tax was NT\$536 million, down 31.3% year over year, and EPS after tax was NT\$1.10. The revenue by product categories: LAN/MAN accounted for 50%, followed by Wireless at 28%, Digital Multimedia at 13%, Mobile & Broadband at 8%, and Others at 1%.
