Alpha Networks Inc. 2006 Fourth Quarter Report

Hsinchu, Taiwan, February 9th, 2007 – Alpha Networks Inc. (Taiwan: 3380.TW) held an investor conference today to discuss results for the quarter ending December 31, 2006, in which revenue reached NT\$5,604 million, net income was NT\$351 million, and earnings per share after tax was NT\$1.04.

On a quarterly basis, revenue decreased 7% from the previous quarter, while net income increased 3%. Revenue by product categories was as follows: LAN/MAN ranked No.1, accounting for 36% of 4Q/06 revenue, followed by Broadband at 29%, Wireless at 21%, VoIP at 7%, and Digital Home 6%. Viewed by business unit, D-Link accounted for 45% of revenues in 4Q, Japan 15%, North America 15%, China 10%, and Europe 9%.

Total revenue of 2006 reached NT\$214.69 million, net income was NT\$1,048 million, and earnings per share after tax was NT\$3.10. Revenue by product categories breaks down as follows: LAN/MAN ranked No.1, accounting for 34% of 2006 revenue, followed by Broadband at 30%, Wireless at 22%, VoIP at 10%, and Digital Home at 4%. By business unit, D-Link captured 45%, Japan 18%, North America 13%, China 13%, and Europe 7%.

According to Alpha Networks' CEO John Lee, 2007's growth will come from Intelligent Switches, Digital Home devices and IP Cameras. According to President Wonder Wang, Alpha will increase the percentage of high-end products. For 2007, both revenue and profit will have impressive performance.
