

Alpha Networks Inc. Reports Fourth Quarter 2015Results

Hsinchu, Taiwan, March 23, 2016 -- Alpha Networks Inc. (TWSE: 3380) today announced its unaudited consolidated financial results for the fourth quarter of 2015.

The consolidated revenue in 4Q15 was NT\$5,370 million, with gross margin 11.9%. Operating loss was NT\$48 million, or -0.9% of net sales. Net loss was NT\$115 million, or -NT\$0.26 per share. 4Q15's revenue by product categories: LAN/MAN accounted for 54% of 4Q15 consolidated revenue, followed by Wireless at 22%, Digital Multimedia at 17%, and Mobile & Broadband at 7%.

The consolidated revenue of 2015 was NT\$22,995 million, with gross margin of 12.6%. Operating margin was NT\$98 million, or 0.4% of net sales. As a result of impairment loss recognition, net loss of 2015 was NT\$340 million, or -NT\$0.74 per share. Revenue by product categories: LAN/MAN accounted for 54% of 2015 consolidated revenue, followed by Wireless at 22%, Digital Multimedia at 16%, and Mobile & Broadband at 8%.

In order to strengthen the competitiveness and profitability, Alpha Networks will continue to focus on efficiency of operation, optimization of product portfolio, cutting-edge technology development and new product deployment for the future growth.
