## Alpha Networks Inc. Reports Second Quarter 2020 Results

Hsinchu, Taiwan, August 10, 2020 -- Alpha Networks Inc. (TWSE: 3380) today announced its consolidated financial results for the second quarter of 2020.

The consolidated revenue for 2Q20 was NT\$7,725 million, up 55.0% from last quarter. The rise was mainly from the increase of Wireless Broadband and Digital Multimedia products, and also consolidating revenue of Hitron. Gross profit increased 49.8% to NT\$1,266 million quarter-over-quarter as a result of consolidating financial statement of Hitron. Operating expenses were NT\$1,016 million or 13.2% of net sales, down 5.5 points quarter -over-quarter. Operating income was NT\$250 million, or 3.2% of net sales. Net income was NT\$277 million. Net income attributable to shareholders of the parent company was NT\$211 million, or NT\$0.39 per share. 2Q20's revenue by product categories: Wireless Broadband accounted for 47% of 2Q20 consolidated revenue, followed by LAN/MAN at 30%, Digital Multimedia at 18%, and Others 5%.

The consolidated revenue for the first half of 2020 was NT\$12,709 million, up 77.4% on a year-over-year basis. Gross profit increased 68.1% to NT\$2,111 million from the prior year as a result of consolidating financial statement of Hitron. Operating expenses were NT\$1,946 million or 15.3% of net sales, down 1.3 points from last year. Operating income was NT\$165 million, or 1.3% of net sales. Net income was NT\$139 million. Net income attributable to shareholders of the parent company was NT\$82 million, or NT\$0.15 per share. 1H20's revenue by product categories: Wireless Broadband accounted for 43% of 1H20 consolidated revenue, followed by LAN/MAN at 35%, Digital Multimedia at 16%, and Others 6%.
