Alpha Networks Inc. Reports Third Quarter 2020 Results

Hsinchu, Taiwan, November 9, 2020 -- Alpha Networks Inc. (TWSE: 3380) today announced its consolidated financial results for the third guarter of 2020.

The consolidated revenue for 3Q20 was NT\$9,671 million, up 25.2% from last quarter. The rise was mainly from the increase of Wireless Broadband and Digital Multimedia products, and also consolidating revenue of Hitron. 3Q20's revenue by product categories: Wireless Broadband accounted for 46% of 3Q20 consolidated revenue, followed by Digital Multimedia at 30%, LAN/MAN at 21%, and Others 3%. Gross profit increased 15.2% to NT\$1,458 million quarter-over-quarter. Operating expenses were NT\$1,081 million or 11.2% of net sales, down 2.0 points quarter -over-quarter. Operating income was NT\$377 million, or 3.9% of net sales. Net income was NT\$264 million. Net income attributable to shareholders of the parent company was NT\$240 million, or NT\$0.44 per share.

The consolidated revenue for the nine months ending September of 2020 was NT\$22,381 million, up 100.8% on a yearover-year basis. 1Q-3Q'20's revenue by product categories: Wireless Broadband accounted for 44% of 1Q-3Q'20's consolidated revenue, followed by LAN/MAN at 29%, Digital Multimedia at 22%, and Others 5%. Gross profit increased 86.7% to NT\$3,570 million from the prior year. Operating expenses were NT\$3,028 million or 13.5% of net sales, down 2.5 points from last year. Operating income was NT\$542 million, or 2.4% of net sales. Net income was NT\$403 million. Net income attributable to shareholders of the parent company was NT\$322 million, or NT\$0.60 per share.
