## Alpha Networks Inc. Reports Fourth Quarter 2020 Results

Hsinchu, Taiwan, March 19, 2021 -- Alpha Networks Inc. (TWSE: 3380) today announced its consolidated financial results for the fourth guarter of 2020.

The consolidated revenue for 4Q20 was NT\$9,790 million, up 1.2% from last quarter. Gross profit was NT\$ 1,437 million. Operating expenses were NT\$1,081 million, or 11.0% of net sales, down 0.2 points quarterover-quarter. Operating income was NT\$355 million, or 3.6% of net sales, down 0.3 points from last quarter. Net income was NT\$235 million, or NT\$0.43 per share. 4Q20's revenue by product categories: LAN/MAN accounted for 23% of 4Q20 consolidated revenue, followed by Wireless Broadband at 39%, Digital Multimedia at 29% and Others at 9%.

The consolidated revenue for 2020 was NT\$32,171 million, up 103.3% year-over-year. Gross profit was NT\$5,006 million; gross margin down to 15.6%, a decrease of 0.9 points. Operating expenses were NT\$4,109 million. Operating income was NT\$898 million, or 2.8% of net sales. Net income was NT\$557 million, or NT\$1.03 per share. 2020 revenue by product categories: LAN/MAN accounted for 27% of 2020 consolidated revenue, followed by Wireless Broadband at 43%, Digital Multimedia at 24% and Others at 6%.
