## Alpha Networks Inc. Reports Second Quarter 2021 Results

Hsinchu, Taiwan, August 10, 2021 -- Alpha Networks Inc. (TWSE: 3380) today announced its consolidated financial results for the second quarter of 2021.

The consolidated revenue for 2Q21 was NT\$7,555 million, up 5.0% and gross profit increased 7.5% to NT\$1,155 million from last quarter. The rise was mainly from the increase of LAN/MAN and Digital Multimedia products. Operating expenses were NT\$977 million or 12.9% of net sales. Operating income was NT\$178 million, or 2.4% of net sales. Net income was NT\$137 million. Net income attributable to shareholders of the parent company was NT\$116 million, or NT\$0.21 per share. 2Q21's revenue by product categories: Wireless Broadband accounted for 42% of 2Q21 consolidated revenue, followed by LAN/MAN at 33%, Digital Multimedia at 20%, and Others 5%.

The consolidated revenue for the first half of 2021 was NT\$14,748 million, up 16.0% on a year-over-year basis. Gross profit increased 5.6% to NT\$2,229 million from the prior year. Operating expenses were NT\$1,900 million or 12.9% of net sales, down 2.4 points from last year. Operating income was NT\$329 million, or 2.2% of net sales. Net income was NT\$254 million. Net income attributable to shareholders of the parent company was NT\$229 million, or NT\$0.42 per share. 1H21's revenue by product categories: Wireless Broadband accounted for 45% of 1H21 consolidated revenue, followed by LAN/MAN at 30%, Digital Multimedia at 20%, and Others 5%.
