

Alpha Networks Inc. Reports Third Quarter 2021 Results

Hsinchu, Taiwan, November 8, 2021 -- Alpha Networks Inc. (TWSE: 3380) today announced its consolidated financial results for the third quarter 2021.

In the third quarter 2021, the consolidated revenue was NT\$6,706 million, decreased 11.2% from last quarter. Wireless Broadband accounted for 45% of consolidated revenue, followed by LAN/MAN at 36%, Digital Multimedia at 14% and others at 6%. Gross profit decreased 0.8% slightly to NT\$1,146 million quarter-over-quarter. Operating expenses decreased 0.8% slightly to NT\$969 million quarter-over-quarter. Operating income was NT\$177 million, or 2.6% of consolidated revenue. Net income was NT\$140 million. Net income attributable to shareholders of the parent company was NT\$112 million, or NT\$0.21 per share, same as second quarter 2021.

In the nine months ended September 2021, the consolidated revenue was NT\$21,454 million, a decrease of 4.1% year-over-year. Wireless Broadband accounted for 45% of the consolidated revenue, followed by LAN/MAN at 32%, Digital Multimedia at 18% and others at 5%. Gross profit decreased 5.5% to NT\$3,375 million year-over-year. Operating expenses were NT\$2,869 million or 13.4% of consolidated revenue, a decrease of 0.1% year-over-year. Operating income was NT\$506 million, or 2.4% of consolidated revenue. Net income was NT\$395 million. Net income attributable to shareholders of the parent company was NT\$341 million, or NT\$0.63 per share, an increase of NT\$0.03 year-over-year.
