

Alpha Networks Inc. Reports First Quarter 2022 Results

Hsinchu, Taiwan, April 29, 2022 -- Alpha Networks Inc. (TWSE: 3380) today announced its consolidated financial results for the first quarter of 2022.

The consolidated revenue for 1Q22 was NT\$6,875 million, down 4.4% year-over-year. Gross margin increased 21.1% to NT\$1,301 million and the rise was mainly from the increase of Wireless Broadband and LAN/MAN products. Due to changes in product portfolio, the gross profit margin in the first quarter of 2022 was 18.9%, an increase of 4.0 points year-over-year. Operating expenses were NT\$1,031 million. Benefited from the growth in revenue and proper control of operating expenses, operating income was NT\$ 270 million, or 3.9% of net sales. Net income was NT\$161 million, or NT\$0.25 per share that performance was better than the same period last year.

1Q22's revenue by product categories: LAN/MAN accounted for 35% of 1Q22 consolidated revenue, followed by Wireless Broadband at 57%, Digital Multimedia at 3%, and Others 5%.

Looking ahead to 2Q22, Ukrainian-Russian war has made tight supply chain constantly and delays in goods shipping resulted from China's Covid lockdowns measures are the main factors that affect revenue and profit.
