Alpha Networks Inc. Reports Third Quarter 2022 Results

Hsinchu, Taiwan, October 27, 2022 -- Alpha Networks Inc. (TWSE: 3380) today announced its consolidated financial results for the third guarter 2022.

In the third quarter 2022, the consolidated revenue was NT\$9,231 million, increased 11.4% from last quarter. Wireless Broadband accounted for 46% of consolidated revenue, followed by LAN/MAN at 42%, Digital Multimedia at 7% and others at 5%. Gross profit increased 0.5% to NT\$1,596 million guarter-over-guarter. Operating expenses decreased 1.5% to NT\$1,129 million quarter-over-quarter. Operating income was NT\$467 million, or 5.1% of consolidated revenue. Net income was NT\$358 million. Net income attributable to shareholders of the parent company was NT\$315 million, or NT\$0.58 per share, increased NT\$0.13 guarter-over-guarter.

In the nine months ended September 2022, the consolidated revenue was NT\$24,393 million, an increase of 13.7% yearover-year. Wireless Broadband accounted for 52% of the consolidated revenue, followed by LAN/MAN at 38%, Digital Multimedia at 5% and others at 5%. Gross profit increased 32.9% to NT\$4,485 million year-over-year. Operating expenses were NT\$3,306 million or 13.6% of consolidated revenue, an increase of 15.2% year-over-year. Operating income was NT\$1,179 million, or 4.8% of consolidated revenue. Net income was NT\$840 million. Net income attributable to shareholders of the parent company was NT\$692 million, or NT\$1.28 per share, an increase of NT\$0.65 year-over-year.
