

Alpha Networks Inc. Reports Fourth Quarter 2023 Results

Hsinchu, Taiwan, February 27, 2024 -- Alpha Networks Inc. (TWSE: 3380) today announced its consolidated financial results for the fourth quarter 2023.

In the fourth quarter 2023, the consolidated revenue was NT\$6,796 million, increased 16% from last quarter. Wireless Broadband accounted for 29% of consolidated revenue, followed by LAN/MAN at 46%, Digital Multimedia at 9% and others at 16%. Gross profit increased 6.4% to NT\$1,262 million guarter-over-quarter. Operating expenses increased 4.6% to NT\$1,131 million quarter-over-quarter. Operating income was NT\$131 million, or 2.0% of consolidated revenue. Net income was NT\$101 million. Net income attributable to shareholders of the parent company was NT\$52 million, or NT\$0.09 per share, decreased NT\$0.06 quarter-over-quarter.

In 2023, the consolidated revenue was NT\$28,272 million, a decrease of 15.9% year-over-year. Wireless Broadband accounted for 40% of the consolidated revenue, followed by LAN/MAN at 46%, Digital Multimedia at 6% and others at 8%. Gross profit decreased 16.7% to NT\$5,211 million year-over-year. Operating expenses were NT\$4,382 million or 15.5% of consolidated revenue, a decrease of 3.5% year-over-year. Operating income was NT\$829 million, or 2.9% of consolidated revenue. Net income was NT\$640 million. Net income attributable to shareholders of the parent company was NT\$548 million, or NT\$1.01 per share, a decrease of NT\$0.68 year-over-year.
