

## Alpha Networks Inc. Reports Second Quarter 2025 Results

Hsinchu, Taiwan, August 1, 2025 -- Alpha Networks Inc. (TWSE: 3380) today announced its consolidated financial results for the second quarter of 2025.

The consolidated revenue for 2Q25 was NT\$5,694 million, increased 25.9%, and gross profit increased 4.6% to NT\$868 million from last quarter. Operating expenses were NT\$997 million or 17.5% of net sales. Operating loss was NT\$129 million, or -2.3% of net sales. Net loss was NT\$139 million. Net loss attributable to owners of parent company was NT\$105 million, or loss NT\$0.19 per share. 2Q25's revenue by product categories: Wireless Broadband accounted for 47% of 2Q25 consolidated revenue, followed by LAN/MAN at 37%, Digital Multimedia at 7%, and Others 9%.

The consolidated revenue for the first half of 2025 was NT\$10,218 million, down 6.0% on a year-over-year basis. Gross profit decreased 12.1% to NT\$1,699 million from the prior year. Operating expenses were NT\$1,936 million or 18.9% of net sales, increased 0.3 percent from last year. Operating loss was NT\$238 million, or -2.3% of net sales. Net loss was NT\$247 million. Net loss attributable to owners of parent company was NT\$211 million, or loss NT\$0.39 per share. 1H25's revenue by product categories: Wireless Broadband accounted for 47% of 1H25 consolidated revenue, followed by LAN/MAN at 37%, Digital Multimedia at 7%, and Others 9%.
