

## Alpha Networks Inc. Reports Third Quarter 2025 Results

Hsinchu, Taiwan, October 31, 2025 -- Alpha Networks Inc. (TWSE: 3380) today announced its consolidated financial results for the third guarter of 2025.

The consolidated revenue for 3Q25 was NT\$5,837 million, increased 2.5%, and gross profit increased 17.1% to NT\$1,017 million from last quarter. Operating expenses were NT\$991 million or 17.0% of net sales. Operating income was NT\$26 million, or 0.4% of net sales. Net income was NT\$27 million. Net income attributable to owners of parent company was NT\$10 million, or NT\$0.02 per share. 3Q25's revenue by product categories: Wireless Broadband accounted for 42% of 2Q25 consolidated revenue, followed by LAN/MAN at 38%, Digital Multimedia at 9%, and Others 11%.

In the nine months ended September 2025, the consolidated revenue was NT\$16,055 million, up 1.5% on a year-over-year basis. Gross profit decreased 6.3% to NT\$2,715 million from the prior year. Operating expenses were NT\$2,927 million or 18.2% of net sales, increased 0.2 percent from last year. Operating loss was NT\$212 million, or -1.3% of net sales. Net loss was NT\$220 million. Net loss attributable to owners of parent company was NT\$201 million, or loss NT\$0.37 per share. 1Q~3Q'25's revenue by product categories: Wireless Broadband accounted for 45% of 1Q~3Q'25 consolidated revenue, followed by LAN/MAN at 37%, Digital Multimedia at 8%, and Others 10%.
