

Alpha Networks Inc. Reports Second Quarter 2026 Results

Hsinchu, Taiwan, July 31, 2026 -- Alpha Networks Inc. (TWSE: 3380) today announced its consolidated financial results for the second quarter of 2026.

The consolidated revenue for 2Q26 was NT\$5,166 million, decreased by 2.8%, and gross profit decreased 6.2% to NT\$915 million from last quarter. Operating expenses were NT\$981 million or 19.0% of net sales. Operating loss was NT\$66 million, or -1.3% of net sales. Net income was NT\$2 million. Net income attributable to owners of the parent company was NT\$8 million, or earnings NT\$0.01 per share. 2Q26's revenue by product categories: LAN/MAN accounted for 39.1% of 2Q26 consolidated revenue, followed by Wireless Broadband at 41.9%, Digital Multimedia at 6.5%, and Others 12.5%.

The consolidated revenue for the first half of 2026 was NT\$10,480 million, up 2.6% on a year-over-year basis. Gross profit increased 11.3% to NT\$1,891 million from the prior year. Operating expenses were NT\$1,952 million or 18.6% of net sales, decreased 0.3 percent from last year. Operating loss was NT\$61 million, or -0.6% of net sales. Net income was NT\$30 million. Net income attributable to owners of the parent company was NT\$61 million, or earnings NT\$0.11 per share. 1H26's revenue by product categories: LAN/MAN accounted for 38.9% of 1H26 consolidated revenue, followed by Wireless Broadband at 43.9%, Digital Multimedia at 6.6%, and Others 10.6%.
