Alpha Networks Inc. 2009 Second Quarter Report

Alpha Networks Inc. (Taiwan: 3380.TW) today announced the unaudited results for the first half and second quarter of 2009.

Total consolidated revenue in the first half of 2009 was NT\$7,544 million, decreased 34% on a YoY basis, net income was NT\$282 million, decreased 36% YoY, and EPS after tax was NT\$0.63. Revenue by product categories was as follows: LAN/MAN accounts for 40% of 1H09 revenue, Wireless at 32%, Broadband plus VoIP at 19%, Digital Multimedia at 7%, and Others at 2%.

Total consolidated revenue of 2Q09 was NT\$4,383 million, increased 39% QoQ, net income after tax was NT\$73 million, decreased 65% QoQ, and EPS after tax of 2Q09 was NT\$0.16. Revenue by product categories was as follows: LAN/MAN accounts for 38% of Q209 revenue, Wireless at 34%, Broadband plus VoIP at 18%, Digital Multimedia at 8%, and Others at 2%.

From next year, Alpha Networks will hold an investor conference once a year to release the financial results for the fourth quarter and will no longer hold an investor conference for the second quarter.
