## Alpha Networks Inc. 2009 Third Quarter Report

Alpha Networks Inc. (Taiwan: 3380.TW) today announced the unaudited results for the third quarter ended September 30, 2009.

Total unaudited consolidated revenue for the nine months ended September 30, 2009 was NT\$12,394 million, decreased 34% on a YoY basis, net income was NT\$513 million, decreased 46% YoY, and EPS after tax was NT\$1.12. Revenue by product categories was as follows: LAN/MAN accounts for 39%, Wireless at 34%, Broadband plus VoIP at 17%, Digital Multimedia at 8%, and Others at 2%.

Total unaudited consolidated revenue of 3Q09 was NT\$4,850 million, increased 11% QoQ, net income after tax was NT\$230 million, increased 215% QoQ, and EPS after tax of 3Q09 was NT\$0.49. Revenue by product categories was as follows: LAN/MAN accounts for 38% of Q309 revenue, Wireless at 38%, Broadband plus VoIP at 14%, Digital Multimedia at 9%, and Others at 1%.
