- > 3Q23 revenues increased 11.2% qoq owing to seasonality and supply chain inventory clearance
- 3Q23 gross margin increase to 5.8% resulting from favorable product mix
- OPEX rate decrease to 4.4% from 4.8% due to effectively cost control
- Non-op expense amounted to NT\$56 million mainly from MTM loss of financial products measured at fair value
- 3Q23 EBIDA amounted to NT\$1.6 billion with net cash of NT\$16.2 billion


